**SUPPLY, INSTALL, TEST AND COMMISSION 3 X 825KVA GENERATORS AT THE PLAYHOUSE COMPANY.**

Inviting proposals from suitable qualified and experienced service providers to design, supply, install, test and commission 3 X 825KVA generators for The Playhouse Company theatre building, 231 Anton Lembede Street Durban.

The Playhouse Company is a Cultural Institution registered in terms of Section 3(1) of the Cultural Institution Act, 1988, to promote the Arts and Culture in Kwa-Zulu Natal.

The scope of the work will include *inter alia*:

- Preparing, constructing the foundation required to install the generators;
- Supplying and installing 3 X 825KVA set of diesel generators and a synchronisation panel;
- Running a full test on the installation;
- Maintaining a maintenance schedule and carry out the full maintenance of the generators;
- Complying with the relevant regulations and standards listed in the tender document.
