Prospective Service Providers wishing to design, supply and install a sound reinforcement loudspeaker system for the Opera theatre at The Playhouse Company, that will form an integral part of any production, are requested to submit proposals. This will include reconfiguring the current Opera loudspeakers system and installing in the Drama Theatre.

The Playhouse Company is a Cultural Institution registered in terms of Section 3(1) of the Cultural Institution Act, 1988, to promote the Arts and Culture in Kwa Zulu Natal.

Closing date for the submission of completed tenders is **20 April 2016 at 11h00**. No late submissions will be considered. Submissions must be enclosed in a sealed envelope and addressed to : The Chief Executive Officer, at above address.

A compulsory site meeting will be held on **24 March 2016 at 10h00** at The Playhouse Company, 231 Anton Lembede Street, Durban.

The scope of the work will include *inter alia*:

- The design, supply and installation of a theatre quality loudspeaker system in the Opera Theatre with remote health monitoring.
- Remove, service and repair the loudspeaker system in the Drama Theatre and reinstall into Opera Theatre as delay loudspeakers.
- Remove, service and repair the loudspeaker system in the Opera Theatre, reconfigure and install in the Drama Theatre.
- Provide commissioning and training.
- Suppliers to provide valid registration numbers from the Office of the Procurement Officer at National Treasury.

Additional requirements are listed below:

- Previous experience in the theatre industry must be disclosed.
- Tender documents submitted without being fully completed, late, faxed or not signed will be disqualified
- BEE Certification is required
- An original valid Tax Clearance certificate is compulsory
- The Playhouse Company is not compelled to accept the lowest proposal.
