REQUEST FOR PROPOSALS – REF PHC 57/2018 DESIGN, MANUFACTURE, SUPPLY AND INSTALL SPIRALIFTS AT THE PLAYHOUSE COMPANY OPERA THEATRE IN DURBAN.

The Playhouse Company is a Cultural Institution registered in terms of Section 3(1) of the Cultural Institution Act, 1988, to promote the Arts and Culture in Kwa-Zulu Natal.

The Company invites proposals from suitable and experienced service providers in designing, manufacturing, supplying and installing of spiralifts in the theatre.

The scope of the work will include *inter alia*:

- Revamp five (5) stage lifts in the Opera Theatre and upgrade the orchestra pit lifts;
- Provide a software that will allow easy operation of the stage lifts and that can be integrated with over stage machinery at a later stage;
- Fix all new motors to the floor of the stage pit and moving platforms to be mounted on the lifting mechanism;
- Reuse the existing platforms;
- The over stage and under stage machinery operation should be controlled at two locations;
- The control panel must be digital and movable;
- Provide a CPU/PLC with backup;
- Supply all the required safety & access control equipment;
- Provide training to the end users and a backup technical support that will be available on call or and on line seven days a week;
- Comply with the relevant regulations and standards.

Pre-qualification requirements are listed below:

- Registration on the National Treasury Central Supplier Database (C.S.D);
- A valid Tax Clearance certificate or a SARS issued pin is compulsory;
- Recent audited financial statements for the past 3 years;
- Proposals must be hand delivered to the address mentioned below.
