






# INTRODUCTION by HEAD OF INSTITUTION





## 4. Festive Season Productions

## 4.1. Production: My Fair Lady

Production Description	This sumptuous staging of one of the world's all-time box office hits was directed by and starred Ralph Lawson, with spectacular new set designs by Andrew Botha and Stan Knight. Lerner and Loewe's classic rags-to-riches musical featured Gina Shmukler and Lisa Bobbert, alternating in the lead role as Eliza Doolittle, the Cockney flower-seller who is transformed into a high society lady, with choreography by Mark Hawkins, costumes by Neil Stuart-Harris and a stellar cast performing to the live accompaniment of the KZN Philharmonic Orchestra under the baton of Naum Rousine.

## 5. NEW STAGES

The Playhouse Company presented its New Stages programme in October, introducing theatre productions that reflected cutting-edge creativity on our performing arts circuit. These included runs in the Drama Theatre of Jay Pather's dance programme, *Body of Evidence*,

featuring Siwela Sonke Dance Theatre, and a gripping drama production entitled *Last Kick of a Dying Horse* by Maduma Productions. The season also featured *Native Blues*, Faca Kulu's a capella musical.

## 5.2. Production: Body of Evidence

Production Description	This piece by Siwela Sonke Dance Theatre was conceived and directed by Jay Pather with music by James Webb, set and videography by Storm Janse van Rensburg, and lighting by Vaughn Sadie. The production explores the mysteries of individual physical memory offset against the concept of a stored flow of knowledge, posing the question, what does a collective nation's memory do with history? Large-scale projections of a cross section of bones and tissue formed the architecture within which the work was performed.





# **FINANCE REPORT**

This is now the 4th consecutive year that the Playhouse Company has achieved an unqualified audit report.

Such a report reflects a considerable achievement, signifying a sound track record of good governance and sound financial controls.

The appointment of the new internal auditors, Sizwe Ntsaluba VSP, for a three-year term, has also contributed to further entrenching the culture of compliance by identifying weaknesses in the internal controls and then advising on control improvement processes.

## **Summary of Highlights**

- The total revenue increased by 47% from R44m to R65m.
- The grant income increase by 46% from R38m to R56m. This is attributable to the capex grant received from DAC to fund the refurbishment of the air-conditioning plant.
- Box office income increased by 77% from R1.7m to R3m. The outstanding turnout for our year end performances contributed to this major achievement.





- Other operating income, including rentals, venue hire, costumes and props hire and donations and sponsorships, increased by 48% from R4.6m to R6.8m. This is largely due to a sponsorship for the staging of a major year-end production.
- The total expenditure decreased by 1% from R54m to R53.6m

## Capital expenditure summary

- © Capital expenditure was approved for the major project replacement of the central air-conditioning plant in an amount of R18 million rands. The work commenced in the January 2010 and was projected to be completed by the end of April 2010.
- Installation by Schindler of the new Front-of-House lift was completed in March 2010
- The Fire Detection System project continued during the year and was scheduled to be completed by the end of May 2010.
- Roof repairs were made to the office block and a section of the main workshop. These buildings have not received any major investment for the past 10 years.
- The installation of CCTV cameras has had the desired effect of maintaining tight security.

#### SUPPORT SERVICES

The Support Services Department worked throughout the year towards achieving the objectives identified in The Playhouse Company's Strategic Plan.

Following successful representations to Central Government, capital expenditure was approved for the major project replacement of the central air-conditioning plant in The Playhouse complex. This work, to the value of R18 million, was undertaken during the first quarter of 2010. This installation will be finished in mid-April 2010.

Installation by Schindler of the new Front-of-House lift was finally completed in March 2010. This project had previously suffered major delays due to technical problems which Schindler rectified at no additional cost to The Playhouse Company.

The Fire Detection System project continued during the year. This upgrade required the installation of detectors in every venue and every room throughout the whole Playhouse Complex.

Our workshops continued to produce the props and scenery needed for stage shows whilst the hiring out of costumes and wigs remained a constant supply of revenue to The Playhouse Company.

Roof repairs were made to the office block and a section of the main workshop. These buildings have not received any major investment for the past 10 years.

Security around The Playhouse continued to be effective and no major disturbances occurred during the year under review. The installation of CCTV cameras has had the desired effect of maintaining tight security.

Following strong motivations and requests for financial support, the Department of Arts & Culture approved a Capital Works Allocation in March 2010 to the value of R9.639 million. The projects authorised will be the replacement of water tanks and all plumbing services at Head Office, upgrading and installation of new dimmers in the theatre venues and modifications to the drive mechanisms on the Opera stage lifts the new year.

Challenges for the coming year will be the motivation for capital expenditure to replace more items of the theatre plant and machinery. The current equipment operates with outdated technology which cannot be maintained at reasonable costs. Its replacement with modern technology is essential to keep The Playhouse a functional and efficient theatre.

#### **HUMAN RESOURCES**

The goals and objectives for the Human Resources Department were formalised into the Strategic Plan in the early stages of the new financial year. The Department's staff complement remained unchanged during the year. This element of stability contributed largely to the attainment of the objectives cited below.

**TRAINING:** The institution spent R300,000 on training throughout the year. This ensured that employees received management, technical and financial skill training. Eighteen employees successfully completed various phases of their respective Adult Literacy training during the year. The programme was highly successful and the external funding obtained for training purposes was extended for the 2010/2011 financial year.

**PERFORMANCE MANAGEMENT:** All employees are subject to performance agreements. Senior managers were assessed twice during the year. Union representatives were briefed on the principles that underpinned the system.

EMPLOYMENT EQUITY: The institution submitted an Employment Equity Report to the Department of Labour, and an Employment Equity Committee was constituted. Committee members were trained in aspects of the Employment Equity Act and the required number of meetings were held. All employees attended a workshop on Diversity and Discrimination.

**STAFF WELFARE:** The institution engaged the services of an external service provider, ICAS, in support of its commitment to provide an Employee Assistance Programme for employees. Employees continue to make use of the services of the programme.

INDUSTRIAL RELATIONS: A wage agreement was signed in terms of which all employees were afforded a 10% increase for the year. Union/Management meetings are held as required, and there were no major issues to report on during the year. The overall relationship between Management and Staff remained healthy.

RECRUITMENT AND SELECTION: The institution lost the services through resignation of the Chief Financial Officer, Marketing Manager and Production Manager. The position of Chief Financial Officer was filled by an internal candidate. The replacements for the other positions are currently being sourced. One employee was dismissed for misconduct.
