4. Complete BOQ inclusive of VAT which agrees to the price stipulated in the bid document.
5. Programme timeline from supply to installation and completion, indicating the different phases of the project.
6. Five (5) written reference letters only, of same or similar value.
7. Letter of Good standing from the Workmen's Compensation Fund (COID).
8. Public Liability.
9. Complete SBD documentation.

**** Failure to comply with ALL the above requirements will result in a disqualification.**
